JOINT CRISIS COMMITTEE: ALLIES

Agenda: The Battle of Dunkirk.

The past serves as a prelude to the present. History repeats itself. It's the year 1940. The month of May. It's an era of doom, an age of chaos. A period of darkness; a future that seems to be inevitably doomed. Within the confines of these four walls, is a group of 15, in which is vested the power to change the course of the world.

The council, headed by the esteemed British Prime Minister, Winston Churchill and the equally important French Head of The State, Paul Reynaud is in a state of confusion, apprehension and chaos. While our valiant men dangle between life and death, evacuation is urgent. It's the need of the hour. A necessity. A compulsion. A sole option, and the only resort.

The council seemed to have been lacking direction, at first. The executive board struggled to develop a sense of purpose in the delegates, but participation was at its least and progress was snail-slow. The members seemed helpless. The Nazi army was continuously closing in; the BEF was stranded and ensnared with the enemy at one end and the horrors of the sea at the other.

What followed was a vigorous exchange of directives between both the cabinets. This, however, didn't mean that the International Press saw intra-cabinet rivalries; in fact, it was quite astonishing to see almost every member participating in formulating directives during the informal sessions. This seemed to please the Executive Board as well. The Supervisor looked into the directives, and ensured that each individual participated. Soon, the cabinet saw a bifurcation of sorts. It was divided into 4 sub committees, each vested with the responsibility of covering certain areas of action in their directives. Ideas were put forth, and were welcomed. War prostitutes, spies, regiment deployment- the committee witnessed all of it. Some even suggested poisoning the food and water supply of the enemy. The council saw some tensions with the United States of America as well, following a word-vomit by Winston Churchill that made things ugly. The guest delegate of USA took the committee by a storm and put forth 3 non-negotiable demands covering the areas of trade,

Joint Crisis Committee: Axis

Agenda: The Battle of Dunkirk.

The meeting of the Cabinet began with the Nazi anthem with the members giving respect to the sacred song. Following the roll call, the committee started with speeches related to the condition of the German military troops surrounding one-third of the French army and the British Expedition Forces on 26th May, 1940.

The German army general Von Kleist declared Italy to be a hypocrite nation. He said that Italy would support any side of the war till the time that side benefits Italy. The minister of armaments and ammunition supported Von Kleist in his opinion. This statement of General Von Kleist spread and soon an Italian representative got to know about it. The president of Italy sent a message to the Nazi Cabinet that Italy would no longer support Axis Powers in this war after being insulted by the German army general.

Following this, general Von Kleist and Fritz Todt decided to resign from the Nazi Cabinet due to their misjudgment of the intentions of Italy and due to their mistake which lead to the loss of Italy's alliance to Axis Powers. Their resignation was declared void by the Nazi Cabinet and the Cabinet's decision to impeach Von Kleist and Fritz Todt was also refused in the following resolution.

Later on, the Halt order by Adolf Hitler was lifted unanimously by the Cabinet and the German forces started moving towards Dunkirk to eliminate the enemy forces which they had surrounded. Due to the Cabinet's effective planning and extremely efficient use of powers, the German u-boats had surrounded and captured over the sea routes near Dover and Portsmouth. This action of the German navy prompted the British evacuation ships to evacuate the Strait of Dover and return to the British territory. The dilligence and efficiency of the Nazi Generals lead to the defeat of the American navy ships in the English Channel leaving the English helpless.

After the plan be was a success, the victory of the Nazis seemed inevitable. The French forces and The BEF in Dunkirk were stuck and the Nazi Panzer division successfully eliminated them. The victory of the Nazis was soon declared and and the Allied forces were defeated.

EMERGENCY MEETING OF THE ARAB LEAGUE, 2011

Agenda: The Arab Spring.

"It all started in December, 2010, when a twenty-six year old fruit seller in rural Tunisia, fed up with a life of harassment and extortion by venal government officials, doused himself in the paint thinner, struck a match, and unwittingly ignited the Arab Spring."

The committee commenced with the General speakers list, the first speaker being the Head of state of Libya, Colonel Muammar Gaddafi, who expressed his disappointment in various news agencies, that had unnecessarily fuelled the Arab Spring. Mr. Bashar Al Assad, the head of state of Syrian Arab Republic publicly displayed his prejudice against the western powers that had aimed to destabilize his government. He further aided to his cause, emphasizing on the fact how he had not violated human rights, and that it was all a media-propaganda. Egypt discussed the core causes of the Arab Spring in a straightforward manner, enlisting the things that the countries needed to come forward to a consensus on. The heads of Reuters and Amnesty International stated that their sites were authentic, on which Libya commented, that majority of media-sites reported hypothetically false news, which consisted of opinions, and not facts.

Syrian Arab Republic put forth an emotional note, so as to how the Arab League kept them together, against all attempts by "UNCLE SAM", a hypothetical name referring to the United States of America. The committee discussed various ways of controlling the crowds via peaceful methods, wherein Djibouti put forth his views, about using pellet guns and teargas on the protesters. This triggered questions from the Executive Board, so as to if Djibouti knew that "teargas had been rendered illegal under the BWC & CWC" and that pellet guns could blind a person, on which he replied that pellet guns and teargas were better than AK47s. The committee became highly diplomatic when Syria shared some sympathy with Col. Gaddafi, on the account that both were leaders, who had been accused of something which they had not done, and received applause from the dictatorships that were present at the headquarters. Out of the blue, came a presidential statement by Colonel Gaddafi, severing all ties with states of Djibouti because of the fabricated remarks and Tunisia for going back on their stance. The committee witnessed a number of presidential statements on both the days.

What seemed like a "constant" committee changed its façade in the face of crises. The communication lines had ben closed, and the crisis contained intel about Syria using up money for "Humanitarian assistance" by Algeria and Russia, so as to lure the unemployed people into supporting his regime, via a rally, the agenda being-"I STAND WITH ASSAD".

The crises went on for long, till the time the committee took a turn from the highways of plain talk, when Libya cited suspicion so as to whether or not to trust the Arab league in a way that Libya thrown out, and then suspiciously called back. Syria said that they would now go on a state of war if they were not compensated for their loss, indirectly blaming Libya for the change in stance. Russia was asked the question by the Executive Board, so as to why it was taking responsibility of the wrong financial decision by Algeria. The committee surprisingly, almost came to a consensus to interrogate the Head officials of the Arab League, about the authenticity of the crisis.

The working paper was tabled three times, a resolution by Syria and Egypt was passed. The committee ended on a solemn note, successfully, on having solved the Arab Spring, and retained the sovereignty of the states of the league.



Agenda: Capital Punishment with Reference to the International Law on Human Rights.

"Just as treasures are uncovered from the earth, so virtue appears from good deeds, and wisdom appears from a pure and peaceful mind. To walk safely through the maze of human life, one needs the light of wisdom and the guidance of virtue." -Buddha

While the death penalty is not prohibited by the International Convenant on Civil and Political Rights (ICCPR) or any other virtually universal international treaty, there are a number of instruments in force with fewer state parties that do abolish capital punishment, the most important treaty provision related to death penalty being the Article 6 of the ICCPR.

At the commencement of the committee session 1, there was hustle-bustle all around and restlessness prevailed in the committee but with the strike of a hammer by the President, all the noise subsided. There was a roll call taken after which began the important discussion on whether "Capital Punishment" must be abolished or mustn't be with each delegate putting forth his/her views. The delegate of Russia could be seen suggesting all the delegates to be more solution-oriented while lobbying which indeed encouraged most delegates to come up with some of the most cerebral solutions. One could see the delegate of the United States of America being targeted the most by the other delegates. To every question posed to most delegates, one could hear bluestocking retorts. Countries like the United States of America and Ghana spoke against capital punishment while countries like the United Kingdom and Slovenia spoke in favour of it.

The delegates expressed themselves indubitably and gallantly. Diplomacy could be seen distinctly. There were multitudinous Formal-Informals raised and a few Informal-Formals to get the committee streamlined. The Speaker's List was opulent with speakers throughout the committee.

There was an indefineable bridge between the delegates and the Executive Board which could be seen in the candid suggestions the Executive Board made and the positive way in which the delegates promised to improve.

The second day had the same eagerness, zeal and enthusiasm amongst the delegates as was there the day before. The logistics were an essential part of the committee and were indeed the most active part of the committee. A lot of speeches and geated debates followed the Speaker's List. With 2 Formal-Informals, with one being attributed to the discussion on working papers, the
